The NMR profile is typical for honey. There were no significant deviations detected according to reference database entries. Regarding the examined parameters the sample corresponds to the legal regulations (Council Directive 2001/110/EC dated Dec. 20th, 2001 relating to honey; Article 1 in connection with Annex II).

Interpretation:

Regarding the examined parameter (chlorate), the mentioned limits of quantification and considering an expanded measurement uncertainty of 50% (SANTE/11312/2021), the sample corresponds to the EU-Regulation 396/2005. Maximum levels for perchlorate in food were set by the Regulation (EU) 2020/685 in conjunction with Regulation (EU) 2023/915. These maximum levels are valid from July 2020. There is still no legal limit in place for this sample. According to the ALARA principle, the perchlorate levels in food should be as low as possible (updated BfR statement No. 006/2018 of February 15, 2018 (Bundesamt für Risikobewertung, German institute for risk assessment)). Regarding the examined parameter and the limit of quantification, the above mentioned sample corresponds to the levels of perchlorate set as reference for intra-Union trade from the Standing Committee on plants, animals, food and feed (SC PAFF) of the European Commission (dated March 16th 2015).
